Dear Council Members:

On behalf of the community of Taylor, Texas, I present to you petitions for enactment of an ordinance in opposition to the location of the proposed Central Texas Regional General Aviation Airport in Taylor, Texas. The petitions were gathered in a five (5) day period.

The petition for an ordinance by direct legislation consists of 172 pages with a total in excess of 1395 signatures of which 1088 are confirmed qualified voters.

The petition states, "The City of Taylor shall not approve the location of the Central Texas Regional General Aviation Airport, a State Airport in Central Texas authorized by Section 21.069 of the Texas Transportation Code, in Taylor, Texas."

We respectfully request that the City Council adopt the petition in the form of an ordinance.

If the City Council fails to act within thirty (30) days, rejects the proposed ordinance or amends the proposed ordinance, we submit that the City Council is required to call an election on the next regular uniform election date. This request is made in accordance with the Article 15 entitled, "Direct Legislation" in the City of Taylor Charter.

Additionally, I am enclosing four (4) pages of signatures of rural land owners that will be affected by the proposed airport and are not interested in selling their land.
