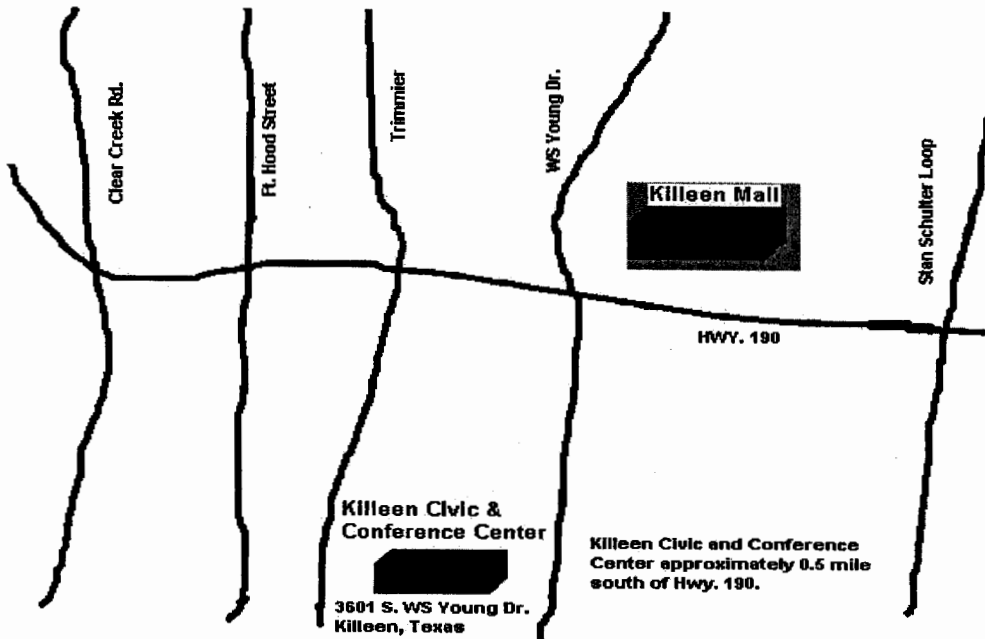

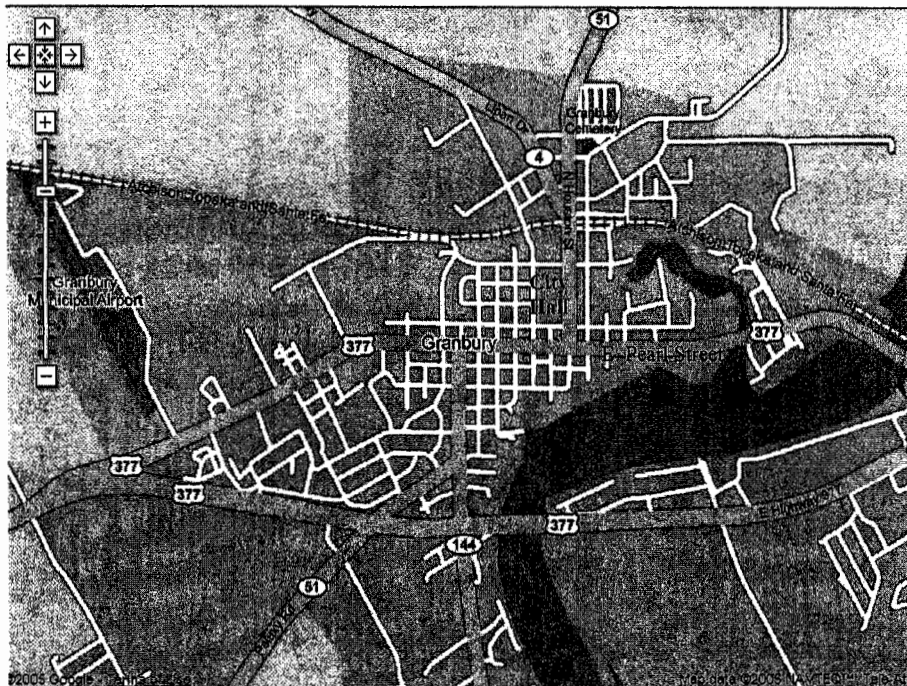
## Central Basin Map/Directions
